TRANSFER OF SUGAR BEET ENTITLEMENTS BY WAY OF SALE, LEASE OR RENTAL AGREEMENT

This application form is designed to enable the transfer of sugar beet entitlements in respect of the 2006 Single Payment Scheme year on the basis of a Sale, Lease or Rental Agreement WHICH WAS ENTERED INTO PRIOR TO 30 April 2006. **A separate form must be completed in respect of each transaction.**

Private Contract Clause to transfer Entitlements in the case of the sale of land.

A Sale Agreement, in place **by 30 April 2006 at the latest**, may be considered as the sale of sugar beet entitlements with land if a clause is included in the sale contract, even if added retrospectively by way of an addendum, indicating that the farmer is selling Entitlements with the land. The vendor must also complete section 1 of the Transfer Application form overleaf.

The purchaser may in turn submit a 2006 Single Payment Application form and use these entitlements for Single Payment purposes in 2006 by including the purchased land in the parcel details on the back page of his/her SPS application form. The purchaser must complete section 2 of the Transfer Application form overleaf.

Private Contract Clause to transfer Entitlements in the case of the lease/rental of land.

A Lease/Rental Agreement, in place **by 30 April 2006 at the latest**, may be considered as the lease/rental of Entitlements with land if a clause is included in the lease/rental agreement, even if added retrospectively by way of an addendum, indicating that the farmer is leasing/renting sugar beet entitlements with the land. The lessee must activate the payment entitlements in the first instance by making a valid Single Payment Scheme application in 2006 and by including the leased/rented land in the parcel details on the back page of his/her SPS application form. The lessee/person renting in must complete section 2 of the Transfer Application form overleaf.

Applicants, who availed of the Private Contract Clause in 2005

Persons, who transferred the entitlements allocated to them in 2005 by way of Private Contract Clause (lease, rental agreement or sale of their lands) must submit a further application form and a copy of the lease agreement, rental agreement or sale contract if a clause is included in the lease agreement, rental agreement or sale contract, even if added retrospectively by way of an addendum, indicating that the farmer is leasing, renting or selling the sugar beet entitlements with the land.

Both Parties must complete this form

This application form must be completed by both parties to the transfer of land and Entitlements and must be submitted by the deadline for the receipt of applications under the 2006 Single Payment Scheme. A copy of the lease/rental agreement or the concluded sale contract (as appropriate) must also be submitted with the completed form.

CLOSING DATE FOR APPLICATIONS TO TRANSFER ENTITLEMENTS
